

Texas Landscape Assessment

Safe House Project did a landscape assessment for Texas to determine the prevention, protection, and prosecution policies and gave suggestions on how to strengthen those policies.

North Carolina Human Trafficking Commission

The North Carolina Human Trafficking Commission annual conference was held in September. Our CEO, Kristi Wells presented on Safe House Certification and bringing standards of care to the restorative care landscape in North Carolina and across the nation in order to better serve survivors with quality care.

Hope Gala

The 3rd annual Hope Gala was a magical evening at the Quail Hollow Club raising \$322K to combat domestic sex trafficking. The night was full of competitive generosity as the thoughts of helping survivors feel safe and hopeful for the first time filled the hearts of everyone who attended.

Inland Empire Health Plan

Our Aftercare Development Director, Alia Dewees, sat on a panel for Inland Empire Health Plan, California's largest state Medicaid providers, discussing identification of human trafficking in healthcare setting and proper trauma-informed reproductive health care for people experiencing trafficking.



Just Conference

Our After Care Development Director, Alia Dewees, attended the JUST Conference in Fort Worth, Texas. She presented to more than 100 organizations and leaders about "Empowering Survivors through Ethical Storytelling."

Speedway Children's Charities

Speedway Children's Charities gave \$100K to be used as a match from the Charlotte Hope Gala. These funds not only allowed us to raise a total of \$322k at the gala, but made a tremendous difference in the lives of survivors as Safe House Project helps them escape their trafficking situation and find hope, freedom, and a future in a safe home.





SHP Gives Away \$500K in Grants

Safe House Project awarded more than \$500k through direct funding and mentorship to help support the launch of 99 new restorative care beds across America. These beds allow survivors to receive crucial healing services following their escape.

HT-NEXT

Our COO & Co-Founder, Brittany Dunn, and Director of Aftercare Development, Alia Dewees, attended American Hotel & Lodging Foundation's session at HT-NEXT. The group discussed tech-driven solutions to eradicating human trafficking and offered inspiration to drive change within the hospitality industry for true community impact.



TVPRA Passed the House

On July 26th, the U.S House of Representatives passed the Frederick Douglass Trafficking Victims Prevention and Protection Reauthorization Act of 2022 (H.R.6552). The bill reauthorizes the historic Trafficking Victims Protection Act of 2000 and provides more than \$1 billion over five years to strengthen both the domestic and international response to human trafficking.

TVPRA Passed the Senate

On December 21st, TVPA bills S. 3946 & S. 3949 passed the Senate. Now it will go back to the House where it needs its final vote. We are one step closer to getting this to the President's desk.

Reauthorizing the TVPA is critical because it reapproves and enhances vital programs that address Human Trafficking.





Certification

10 Programs went through the certification process this year. Through this process, the home is evaluated against evidence-based and promising practices. These programs work every day to provide a trauma-informed, supportive, and therapeutic residential program for survivors. Congratulations on being Safe House certified!

Rock N Roll Charity Partners

Safe House Project's Team Protectors ran in the United Airlines Rock'N'Roll Half Marathon. The team raised over \$13.5K for our emergency fund, which provides emergency extraction, transportation, and safe house placement to survivors exiting their trafficking situation. Virginia Governor's Commission

Safe House Project is honored to announce that our Co-Founder & COO, Brittany Dunn, and Content Creator and Survivor Leader, Sarah-Beth Evans were sworn in by Virginia Governor Glenn Youngkin to the Virginia Commission on Human Trafficking Prevention and Survivor Support.

United Nations

Our CEO, Kristi Wells, was honored to be in New York with the United Nations as part of a discussion on the deep need to train healthcare workers to identify and respond to human trafficking with the World Health Organization. Thank you to The Permanent Observer Mission of the Sovereign Order of Malta to the United Nations and Global Strategic Operatives for your leadership on this effort domestically and internationally.





Law Enforcement Training

Our COO, Brittany Dunn, and Bill Woolf from The Woolf Group conducted a full day law enforcement training. This training taught law enforcement officers how to confront suspected trafficking and support survivors in a trauma-informed way.

OnWatch Teacher's Training

Educators Training Portal launched—which includes a high-impact 30-minute training curated to empower educators as they prepare to go back to school.

In North Carolina alone, over 3,000 teachers have been trained to spot, report, and prevent trafficking within their school systems.
